EXHIBIT RULES & APPLICATION

You are invited to present a part of your collection via an educational exhibit at the 2018 NCNA Convention and Show to be held at the Cabarrus Arena and Events Center in Concord, North Carolina. The show is open to the public Friday, Saturday and Sunday, October 5th through 7th.

Exhibit Rules

1. Exhibiting is open to all members of the NCNA. Non-members wishing to exhibit may join the NCNA prior to the Convention to gain eligibility.
2. All exhibited material must be the property of the exhibitor.
3. All exhibits must be prepared and set up by the exhibitor. An agent for an exhibitor may set up and/or take down an exhibit if prior arrangements are made with the Exhibit Chair.
4. Any exhibited material known to be a copy or replica must be labeled as such. Failure to do so will disqualify an exhibit from receiving an award.
5. The exhibitor should not be identified in the exhibit; exhibits are not to include the exhibitor's name, image or any other material specifically identifying him or her. A waiver of this rule will be granted to an exhibitor placing a non-competitive exhibit.
6. Exhibits may be set up on Thursday, October 4th between 4:00pm and 8:00pm or on Friday, October 5th or Saturday, October 6th beginning at 8:00am. All exhibits must be in place by 10:00am Saturday, October 6th. *Note: To be eligible for the "Best of Show" award, an exhibit must be in place by the close of the bourse on Friday, October 5th.*
7. Exhibits may not be removed before Noon on Sunday, October 7th unless special permission is obtained from the Exhibit Chair.
8. Exhibits must be removed by 4:00pm on Sunday, October 7th.
9. Exhibit cases will be furnished upon request; however, an exhibitor may furnish his or her own case(s). The interior dimensions of the cases available from the NCNA are approximately 20-3/4" by 32-3/4".
10. An exhibitor may enter more than one exhibit, but no more than three. The maximum number of cases per exhibitor is ten (10). The Exhibits Chair reserves the right to limit the number of exhibits or the case count per exhibit based on the number of exhibit applications received.
11. Noncompetitive exhibits will be welcomed if space permits; such inclusion is at the discretion of the Exhibit Chair.
12. A "Best of Show" award will be given for competitive exhibits in the Senior and Junior categories. The Junior category is open to those 17 years of age or younger as of the first day of the Convention.
13. A "People's Choice" award will be presented to the exhibit garnering the most votes from Convention attendees.
14. The Exhibit Chair is not eligible for the "Best of Show" award. All other officers, board members and members in good standing of the NCNA may exhibit competitively.
15. The decisions of the Exhibit Chair are final.
16. The North Carolina Numismatic Association will provide 24-hour bourse floor security, but all exhibits are displayed at the risk of the owner. The North Carolina Numismatic Association assumes NO liability for loss of or damage to any items exhibited.
