Conditions, Agreement and Release

1. There is no sales tax on coins, currency or bullion in North Carolina.
2. Uniformed police officers will provide 24-hour security from Thursday, 2 pm until Sunday, 5 pm.
3. Dealer credentials are limited to 3 per 8-ft table.
4. Dealers may not sublet or share table space or move tables without prior consent of the Bourse Chair.
5. All persons on the floor during non-public hours and all persons behind dealer tables must wear NCNA-issued credentials.
6. Any Dealer offering counterfeit, altered or other spurious material, or who conducts him/herself in a manner deemed detrimental to the benefit of the Convention and Show, will be subject to expulsion from the show without recourse.
7. Unless prior arrangements have been made with the Bourse Chair, tables that are not occupied by 3 pm Friday, or are abandoned by 3 pm Saturday, revert to the NCNA.
8. The Bourse Chair has final say on all issues relating to the show.
9. The NCNA and the Cabarrus Arena and Events Center and their officials shall not be deemed or held financially liable, in either their individual or official capacity, for any monetary loss, damage, or physical injury that may be incurred and/or sustained by any dealer assigned a booth on the floor, their agents, contractors or employees and/or their personal property, either at or subsequent to the event.

All tables come with an electrical outlet and an 8-ft backup table, two customer chairs for an 8-ft table, four customer chairs for a corner table, and two dealer chairs.
