The NCNA and the Cabarrus Arena and Events Center and their officials shall not be deemed or held financially liable, in either their individual or official capacity, for any monetary loss, damage, or physical injury that may be incurred and/or sustained by any dealer assigned a booth on the floor, their agents, contractors or employees and/or their personal property, either at or subsequent to the event.
